

INDIVIDUAL USER AGREEMENT

Last updated January 12, 2022. Replaces the prior version in its entirety.

As a registered user on the site purchasing an online subscription, you agree to the following terms and conditions:

1. **THIS AGREEMENT** between the American Society of Civil Engineers ("ASCE") and you ("You" or "User") grants you the right to access the specific digital content for which you maintain an active, paid subscription, including any supplementary parts thereof ("Licensed Materials") which are made available through the ASCE 7 Online platform ("Service"), subject to the terms and conditions set forth in this Agreement. ASCE reserves the right, at its discretion, to change, modify, or remove any of these Terms of Use ("Terms") at any time. Notice of such changes will be posted on the Service. All purchases under this Agreement are non-transferable and non-refundable. This Agreement will become effective upon purchase by the User.

TERMS and CONDITIONS

2. **Authorized User.** ASCE's grant to you of online access to Licensed Materials on the ASCE 7 Online platform for which you maintain a current subscription extends only to you individually and may not be transferred to or extended to others. You agree to maintain your User ID and Password as private and confidential information. Unauthorized use of the User ID and password for online access to the Service, with or without the User's knowledge, is a breach of this Agreement and a violation of ASCE's copyrights.

3. **Permitted Access and Use.** The User is permitted to access, view, or print text by chapter or section, search results, or other information from the Licensed Materials for the private use of the individual User. The User agrees to use this online access in a way that conforms with all applicable laws and regulations. The User specifically agrees not to make any attempt to gain unauthorized access to any other system or network.

ASCE grants the User permission to reprint brief quotations from the content included in the Licensed Materials with the customary acknowledgment of the source. Unless expressly authorized in this Agreement or within the Licensed Materials, any other use of the Licensed Materials requires the written permission of the copyright holder.

4. **Term and Termination.** ASCE grants you online access to each subscription purchased through your Service account as long as you maintain a current online subscription to the ASCE 7 Online platform. The term of this paid subscription is twelve (12) months from receipt of payment and activation of license. This agreement will terminate: (a) if the paid subscription lapses at the end of the subscription term; (b) if any term or condition of the Agreement is violated for any reason, knowingly or unknowingly; or (c) if following thirty (30) days prior written notice by ASCE of any change in the terms of this Agreement, receipt by ASCE of notice from you in writing, or by e-mail or by fax that you do not accept such change or changes. (In the absence of any such objection by Subscriber, ASCE's new terms shall apply.)

5. Prohibitions on Certain Uses. Altering, recompiling, copying, reselling, redistributing, publishing or republishing (except as otherwise provided in Section 3) of any text, output, search results, or other information from the Licensed Materials, or any portion thereof, including without limitation, copyright, trade secret, proprietary and/or other legal notices contained therein, in any form or medium is prohibited. Systematic or programmatic downloading (for example downloading an entire standard), service bureau redistribution services and/or the making of print or electronic copies for transmission to third parties are prohibited. All rights not expressly granted are reserved to ASCE.

ASCE shall not be required to distribute, and User shall not redistribute, any Licensed Materials to a country where the export thereof is prohibited by U.S. law or regulation.

6. Annotations. All annotations created by the User are the property and responsibility of the User and can only be viewed by those that have access to the paid, active subscription and user account. ASCE does not have access to personal annotations created by individual users.

7. Copyright. You understand and agree that Licensed Materials, including descriptions and abstracts, are copyrighted by ASCE and are subject to all applicable copyright, database protection, and other rights of ASCE as copyright owner and publisher under the laws of the United States and other countries. Copyright notices in the Licensed Materials may not be removed, obscured, or modified in any way. Unauthorized copying or redistribution of any Licensed Materials is a violation of copyright laws.

8. Failure of Performance. Following approval for online access, the User will be permitted to attempt online access to the Licensed Materials for which the User maintains a current subscription. ASCE will not be liable for any delay, downtime, access time error, transmission error, software or equipment incompatibilities, force majeure, or other failure of performance. ASCE will use commercially reasonable efforts to correct any material performance problem brought to its attention and may suspend performance pending such correction.

9. Usage Rights of Lapsed Subscribers. Upon lapse of subscription, no additional service is provided, and no personal settings or annotations will be saved.

10. Disclaimer of Warranties; Limitation of Liability; Indemnification. ASCE warrants that it is entitled to grant the licenses granted in this Agreement. EXCEPT AS SET FORTH IN THE PRECEDING SENTENCE, ASCE MAKES NO WARRANTY OR REPRESENTATION OF ANY KIND, EXPRESS OR IMPLIED, WITH RESPECT TO THE LICENSED MATERIALS, INCLUDING ITS QUALITY, ORIGINALITY, SUITABILITY, SEARCHABILITY, OPERATION, PERFORMANCE, COMPLIANCE WITH ANY COMPUTATIONAL PROCESS, MERCHANTABILITY, OR FITNESS FOR A PARTICULAR PURPOSE. THE LICENSED MATERIALS ARE LICENSED AND PROVIDED TO YOU ON AN "AS IS" BASIS.

ASCE SHALL NOT BE LIABLE FOR: EXEMPLARY, SPECIAL, INDIRECT, INCIDENTAL, CONSEQUENTIAL, OR OTHER DAMAGES, ARISING OUT OF OR IN CONNECTION WITH THE

SUBSCRIPTION OR LICENSES GRANTED HEREUNDER; THE USE OR INABILITY TO USE ANY ASCE ONLINE PUBLICATION; ASCE'S PERFORMANCE UNDER THIS AGREEMENT; TERMINATION OF THIS AGREEMENT BY ASCE; OR THE LOSS OF DATA, BUSINESS, OR GOODWILL, EVEN IF ASCE IS ADVISED OR AWARE OF THE POSSIBILITY OF SUCH DAMAGES. IN NO EVENT SHALL THE TOTAL AGGREGATE LIABILITY OF ASCE FOR ANY CLAIMS, LOSSES, OR DAMAGES ARISING OUT OF OR IN CONNECTION WITH THIS AGREEMENT EXCEED THE GREATER OF ONE HUNDRED AND FIFTY-EIGHT DOLLARS (\$158.00) OR THE TOTAL AMOUNT PAID BY THE USER TO ASCE FOR THE LICENSED MATERIAL, FOR THE CURRENT YEAR IN WHICH SUCH CLAIM, LOSS, OR DAMAGE OCCURRED, WHETHER IN CONTRACT, TORT, OR OTHERWISE, INCLUDING WITHOUT LIMITATION DUE TO NEGLIGENCE. The foregoing limitation of liability and exclusion of certain damages shall apply regardless of the success or effectiveness of other remedies. No claim may be made against ASCE unless suit is filed thereon within one (1) year after the event giving rise to the claim.

The User assumes sole responsibility for all use of Licensed Materials and agrees to indemnify and hold ASCE and its officers, directors, employees, members, and agents, harmless from and against any and all claims, liabilities, damages, expenses (including attorneys' fees and experts' costs, penalties, and fees, if any, for the enforcement of this Agreement and otherwise for ASCE's defense of indemnified claims), losses and threatened losses arising from or in connection with any breach of this Agreement, including without limitation, claims of unauthorized use.

11. General. This Agreement constitutes the entire agreement between the parties and supersedes any prior communication between the parties with respect to the subject matter hereof. Except as otherwise provided in Section 4, this Agreement may be amended only by consent (via mail, e-mail, or fax) of both parties. The headings used in this Agreement are for convenience only and are not to be considered in construing the terms of this Agreement.

The User may not assign or transfer its rights under this Agreement. The provisions of Sections hereof shall survive any expiration or termination of this Agreement.

This Agreement will be governed by, and construed in accordance with, the laws of the Commonwealth of Virginia, applicable to contracts entered into and fully performed in the Commonwealth of Virginia, without regard to the conflict of laws provisions therein. Any action arising out of or relating to this Agreement shall be brought in courts situated in Fairfax County, Virginia, and the parties consent to the jurisdiction of such courts.
